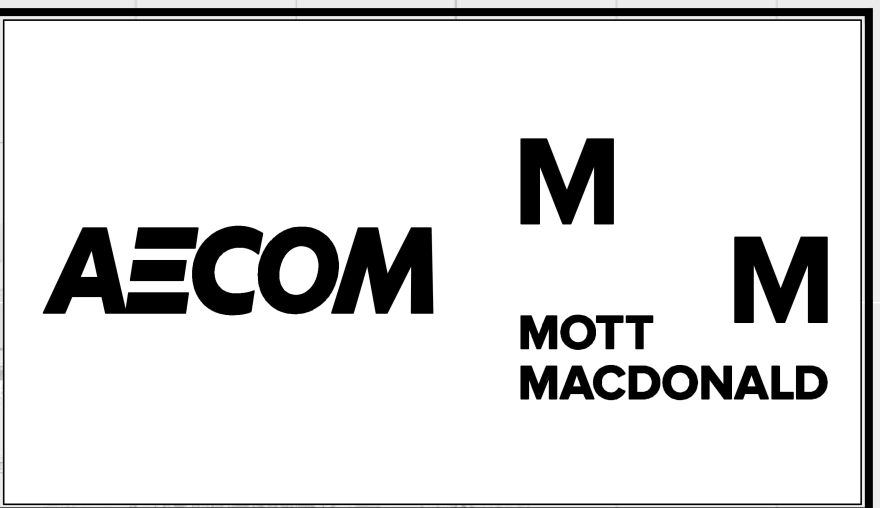


Site Location Map







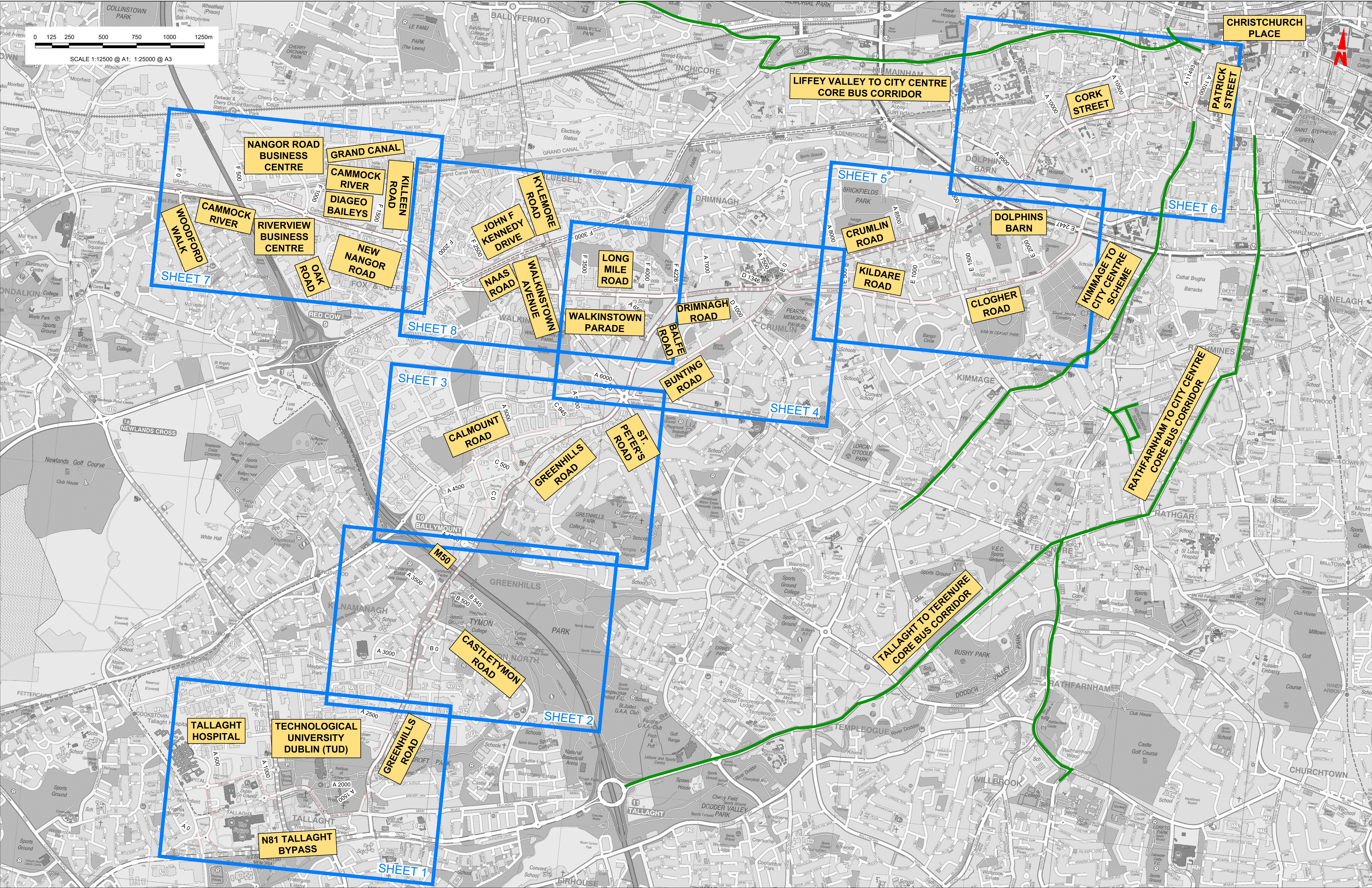

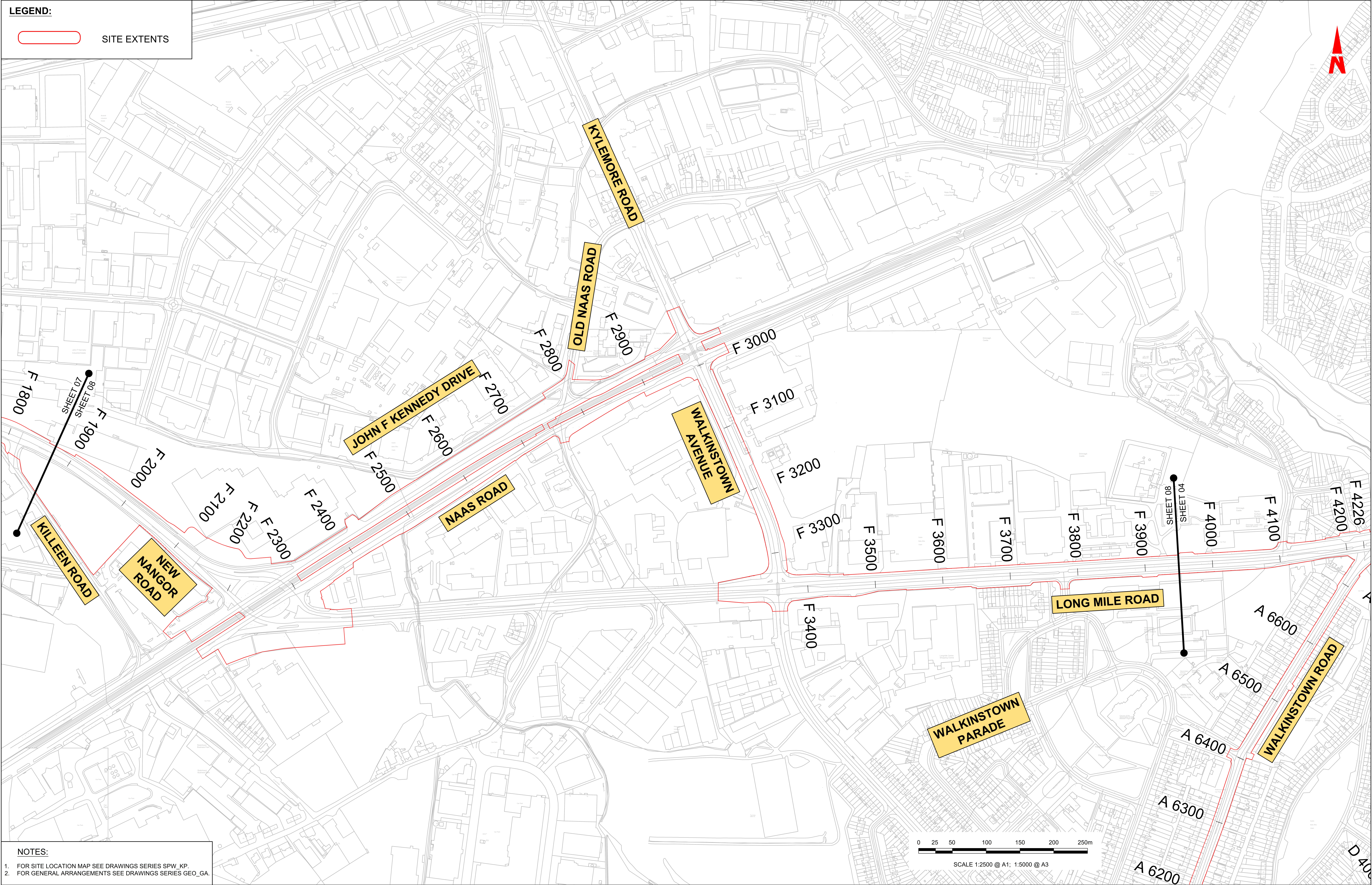
