Ón áit sin, tá an Scéim Bheartaithe ródaíthe feadh Bhóthar na nGlaschnoc/an R819 go Timpeallán Bhaile Bhailcín trí nascbhóithre nua: sa limistéar glas lastoir d'Ascaill Radharc na Beithe/Bóthar Ghort na gCrann; sa limistéar glas laistear d'Ascaill Bhaile an Mhóta, agus sa limistéar glas lastoir de Bhóthar Calmount. Ó Thimpeallán Bhaile Bhailcín, tá an phríomh-Chroíchonair Bus ródaíthe feadh Bhóthar Bhaile Bhailcín/an R819 go dtí an t-acomhal le Bóthar an Mhíle Fhada/an R110 agus le Bóthar Dhroimeanaigh. Is é an t-acomhal sin pointe tosaithe na coda ó Chluain Dolcáin go Droimeanach, agus tá an Scéim Bheartaithe ródaíthe feadh an R110 go dtí an t-acomhal idir Sráid an Déin agus Sráid Phádraig trí Bhóthar Dhroimeanaigh, Bóthar na Cromghlinne, an Carnán, Sráid Chorcaí, Ascaill Lúcaís agus Sráid an Déin. Ón áit sin, tá an Scéim Bheartaithe ródaíthe feadh an R137 trí Shráid Phádraig go dtí an t-acomhal idir Sráid an Fhíona agus Plás Theampall Chríost, áit a gcríochnaíonn an Scéim Bheartaithe laistigh de Lár na Cathrach. Maidir leis an gcuid ó Chluain Dolcáin go Droimeanach, tá sí ródaíthe feadh Bhóthar Nangair Nua/an R134, Bhóthar Náis/an R810, Ascaill Bhaile Bhailcín/an R112 agus Bhóthar an Mhíle Fhada/an R110 go dtí an t-acomhal idir Bóthar Bhaile Bhailcín agus Bóthar Dhroimeanaigh, áit a gcomhcheanglóidh sí leis an gcuid ó Thamhlacht go Lár na Cathrach den Scéim Bheartaithe. Áirítear leis an Scéim Bheartaithe saoráid rothaíochta as líne idir Timpeallán Bhaile Bhailcín agus Bóthar Parnell (an Chanáil Mhór) lena soláthrófar bealach níos díri i dtreo na cathrach trí Bhóthar Bunting, Bóthar Chill Dara agus Bóthar an Chlochair, a bhfuil gach ceann díobh lonnaithe i gContae Bhaile Átha Cliath agus laistigh de limistéir riaracháin Chomhairle Contae Bhaile Átha Cliath Theas agus Chomhairle Cathrach Bhaile Átha Cliath, arb é a bheidh inti, i measc nithe eile:

- 29.2 km (déthro) de bhonneagar tosaíochta bus agus de bhainistíocht tráchta;
  - 38.5 km (san iomlán sa dá threo) de bhonneagar rothaíochta agus de shaoráidí rothaíochta;

  - 64 cinn nua/athchóirithe de shaoráidí taobhiontrála tábla ardaithe;
  - Stadanna bus láithreacha a athchumrú, a fhágfaidh go mbeidh 19 stad bus nua agus 64 shaoráid stad bus nua ann;
  - Oibreacha Ríochta Poiblí, lena n-áirítear tírdhreachú, cur, troscán sráide, soilsiú sráide, ballaí coinneála, ballaí teorann agus bearta draenála uirbí inbhuanaithe;
  - Oibreacha talún a bhaineann le bóithre, lena n-áirítear ábhar do-ghlactha a thochailt, ábhar a allmhairiú agus ábhair a stóráil go sealadach;

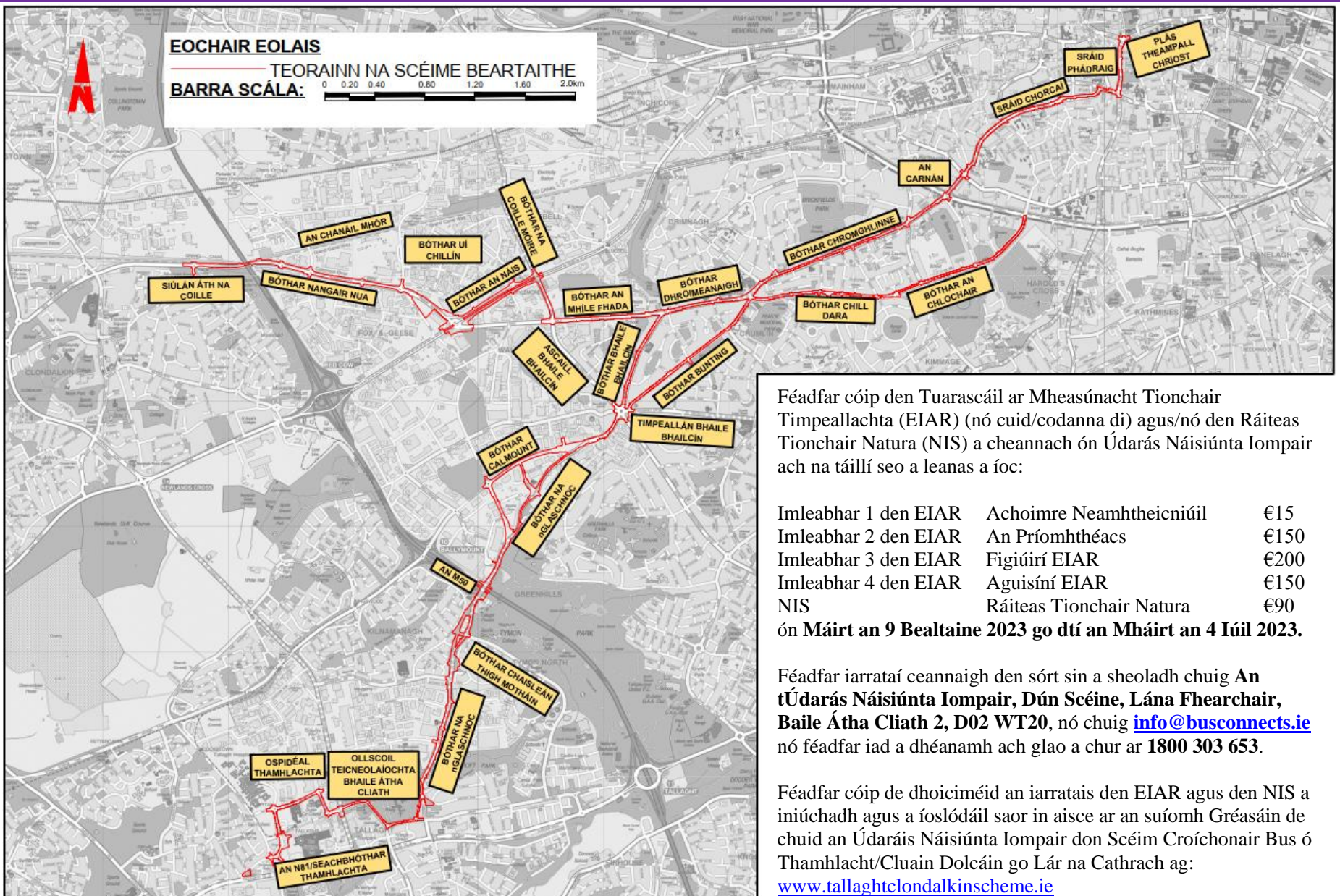

## **TALLAGHT / CLONDALKIN TO CITY CENTRE CORE BUS CORRIDOR SCHEME**

The National Transport Authority (NTA) has applied under section 51(2) of the Roads Act 1993 (as amended) to An Bord Pleanála ('the Board') for approval in relation to a proposed road development consisting of:

The construction of the Tallaght / Clondalkin to City Centre Core Bus Corridor Scheme, which has an overall length of approximately 15.5km from end to end with an additional offline cycling facility approximately 3.9km in length consisting of two sections, namely the Tallaght to City Centre section and the Clondalkin to Drimnagh section. The Tallaght to City Centre section is routed along Belgard Square West, Belgard Square North, Belgard Square East, Blessington Road, Main Road, Old Greenhills Road to the junction of Greenhills Road and Bancroft Park. From here the Proposed Scheme is routed along the R819 Greenhills Road to Walkinstown Roundabout via new link roads; in the green area to the east of Birchview Avenue/Treepark Road; in the green area to the south of Ballymount Avenue, and in the green area to the east of Calmount Road. From Walkinstown Roundabout the main Core Bus Corridor is routed along the R819 Walkinstown Road to the junction with R110 Long Mile Road and Drimnagh Road. The Clondalkin to Drimnagh section commences at this junction and the Proposed Scheme is routed along the R110 to the junction of Dean Street and Patrick Street via Drimnagh Road, Crumlin Road, Dolphins Barn, Cork Street, St Luke's Avenue and Dean St. From here the Proposed Scheme is routed along the R137 via Patrick Street to the junction at Winetavern Street and Christchurch Place where the Proposed Scheme terminates within the City Centre. The Clondalkin to Drimnagh section is routed along the R134 New Nangor Road, R810 Naas Road, R112 Walkinstown Avenue and the R110 Long Mile Road to the junction of Walkinstown Road and Drimnagh Road, where it will join the Tallaght to City Centre section of the Proposed Scheme. The Proposed Scheme includes an offline cycle facility between Walkinstown Roundabout and Parnell Road (Grand Canal) which provides a more direct route towards the city via Bunting Road, Kildare Road and Clogher Road, all in the County of Dublin and within the South Dublin County Council (SDCC) and Dublin City Council (DCC) administrative areas, comprising inter alia:

- 29.2 km (two-way) of bus priority infrastructure and traffic management;
- 38.5 km (total both directions) of cycling infrastructure and facilities;
- A new bus interchange at Tallaght;
- Two new pedestrian/cyclist bridges over the M50 adjacent to the Greenhills Road overbridge;
- Five new pedestrian/cyclist bridges over the New Nangor Road / Naas Road / Long Mile Road junction;
- Provision of new/refurbished pedestrian facilities and footpaths along the scheme and associated ancillary works;
- Provision of 59 junction upgrades and associated ancillary works;
- Provision of 64 new/refurbished raised table side entry facilities;
- Reconfiguration of existing bus stops resulting in 19 new bus stops and 64 number new bus stop facilities;
- Public Realm works including landscaping, planting, street furniture, street lighting, retaining walls, boundary walls and sustainable urban drainage (SUDs) measures;
- Roads associated earthworks including excavation of unacceptable material, importation of material, temporary storage of materials;
- Provision of road pavement, signing, lining and ancillary works;
- Provision of gates, fencing and boundary treatment works;
- Provision of new and diverted drainage infrastructure;
- Diversion of utilities and services including associated ancillary works; and
- Construction of accommodation works including boundary treatment and ancillary grading and landscaping works; together with all ancillary and consequential works associated therewith.

The location of the proposed road development is illustrated in the accompanying map. The NTA has submitted to the Board the Environmental Impact Assessment Report prepared in accordance with Section 50 of the Roads Act 1993 (as amended) and Directive 2011/92/EU of the European Parliament and of the Council of 13 December 2011 on the assessment of the effects of certain public and private projects on the environment as amended by Directive 2014/52/EU of the European Parliament and of the Council of 16 April 2014 in respect of the proposed road development.

A Natura Impact Statement has also been prepared and has been submitted to the Board in respect of the proposed road development under Part XAB of the Planning and Development Act 2000 (as amended).

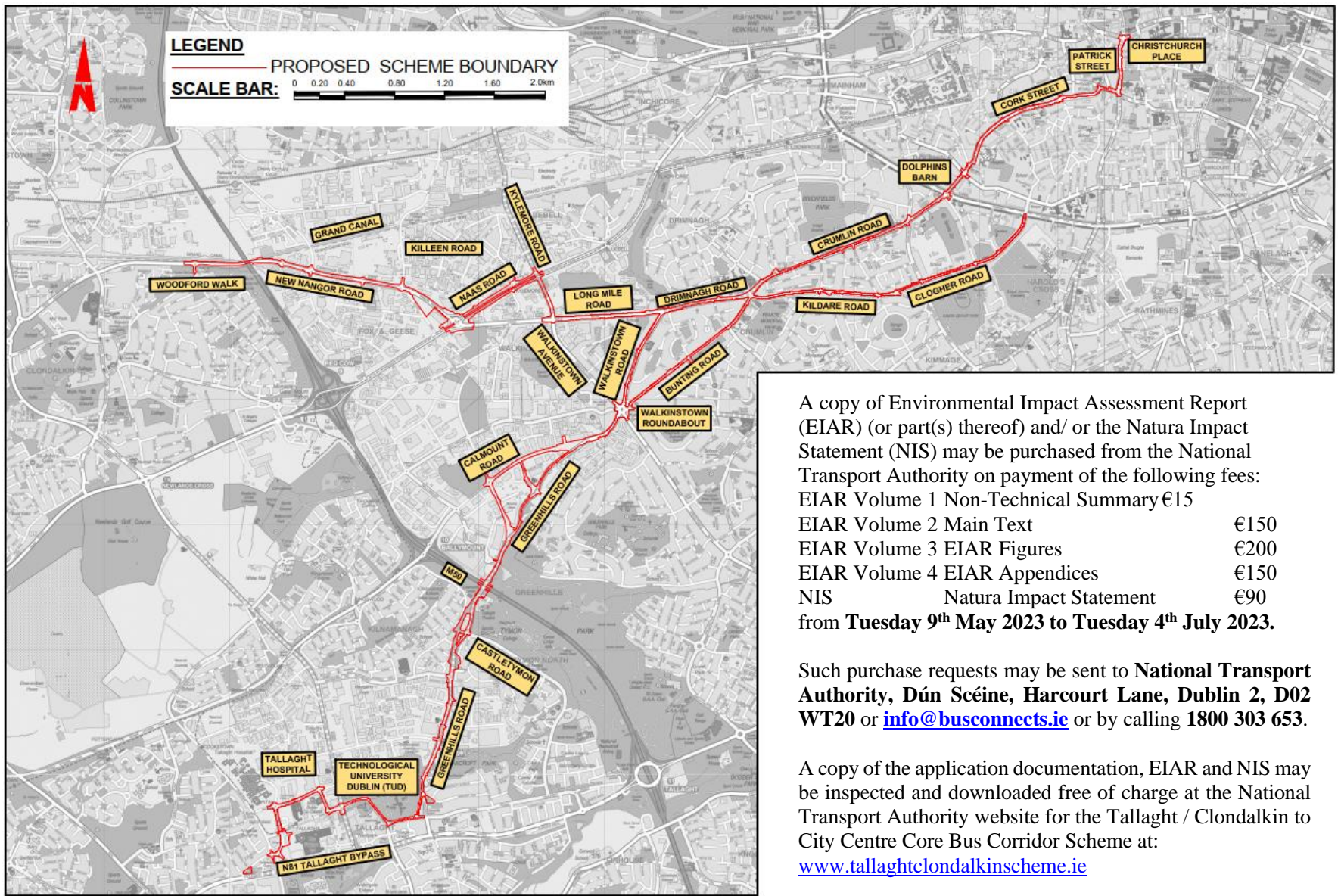

Maidir leis an gcuid ó Thamhlacht go Lár na Cathrach, is é an t-acomhal idir Seanbhóthar Bhaile Coimín agus Bealach Bhaile an Chócaigh a pointe tosaithe agus tá sí ródaith feadh Chearnóg Belgard Thiar, Chearnóg Belgard Thuaidh, Chearnóg Belgard Thoir, Bhóthar Bhaile Coimín, an Bhóthair Mhóir agus Sheanbhóthar na nGlaschnoc go dtí an t-acomhal idir Bóthar na nGlaschnoc agus Páirc Bancroft. Is é an t-acomhal sin pointe tosaithe na coda ó Chluain Dolcáin go Droimeanach, agus tá an Scéim Bheartaithe ródaith feadh an R110 go dtí an t-acomhal idir Sráid an Déin agus Sráid Phádraig trí Bhóthar Dhroimeanaigh, Bóthar na Cromghlinne, an Carnán, Sráid Chorcaí, Ascaill Lúcaís agus Sráid

The National Transport Authority (hereinafter referred to as the “NTA”) in exercise of the powers conferred upon them by Section 76 of the Housing Act, 1966, and the Third Schedule thereto, as extended by Section 10 of the Local Government (No. 2) Act, 1960 as substituted by Section 86 of the Housing Act, 1966 as amended by Section 6 and the Second Schedule to the Roads Act, 1993 and as amended by the Planning and Development Act, 2000 (as amended), Section 184 of the Local Government Act 2001 and Section 44 of the Dublin Transport Authority Act 2008 (as amended), have made an order entitled as above which is about to be submitted to An Bord Pleanála for confirmation.

If confirmed, the order will authorise the NTA to acquire compulsorily the land and/or rights described in Part I, Part II and Part IV (Section A) of the Schedule hereto for the purposes of construction of the Tallaght / Clondalkin to City Centre Core Bus Corridor Scheme for the purposes of facilitating public transport, and together with all ancillary and consequential works associated therewith. The Tallaght / Clondalkin to City Centre Core Bus Corridors of the CBC Infrastructure Works measures approximately 15.5km with an additional offline cycling facility approximately 3.9km in length consisting of two sections, namely the Tallaght to City Centre section and the Clondalkin to Drimnagh section. The Tallaght to City Centre section commences at the junction of Old Blessington Road / Cookstown Way and is routed along Belgard Square West, Belgard Square North, Belgard Square East, Blessington Road, Main Road, Old Greenhills Road to the junction of Greenhills Road and Bancroft Park. From here the Proposed Scheme is routed along the R819 Greenhills Road to Walkinstown Roundabout via new link roads; in the green area to the east of Birchview Avenue/Treepark Road; in the green area to the south of Ballymount Avenue, and in the green area to the east of Calmount Road. From Walkinstown Roundabout the main Core Bus Corridor is routed along the R819 Walkinstown Road to the junction with R110 Long Mile Road and Drimnagh Road. The Clondalkin to Drimnagh section commences at this junction and the Proposed Scheme is routed along the R110 to the junction of Dean Street and Patrick Street via Drimnagh Road, Crumlin Road, Dolphins Barn, Cork Street, St Luke's Avenue and Dean St. From here the Proposed Scheme is routed along the R137 via Patrick Street to the junction at Winetavern Street and Christchurch Place where the Proposed Scheme terminates within the City Centre. The Clondalkin to Drimnagh

section, begins at the junction of New Nangor Road and Woodford Walk and is routed along the R134 New Nangor Road, R810 Naas Road, R112 Walkinstown Avenue and the R110 Long mile Road to the junction of Walkinstown Road and Drimnagh Road, where it will join the Tallaght to City Centre section of the Proposed Scheme. The Proposed Scheme includes an offline cycle facility between Walkinstown Roundabout and Parnell Road (Grand Canal) which provides a more direct route towards the city via Bunting Road, Kildare Road and Clogher Road, all in the County of Dublin and within the South Dublin County Council (SDCC) and Dublin City Council (DCC) administrative areas.

Owners, lessees and occupiers of the land and/or rights described in Part I, Part II and Part IV of the Schedule will receive individual written notice.

The order will authorise the NTA to extinguish the public rights described in Part III (Section A) of the Schedule hereto, by order made by it after it has acquired the land, where the said public rights are over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof.

The order will authorise the NTA to restrict or otherwise interfere with the public rights described in Part III (Section B) of the Schedule.

The order will authorise the NTA to restrict or otherwise interfere with the private rights described in Part IV (Section B) of the Schedule.

The order will authorise the NTA to temporarily restrict or otherwise interfere with the private rights described in Part IV (Section C) of the Schedule.

Any objection to the order should be made in writing to **An Bord Pleanála (Strategic Infrastructure Division), 64 Marlborough Street, Dublin 1, D01 V902**, so as to reach the said Board before **5.30pm on Tuesday 4<sup>th</sup> July 2023**.

The Board cannot confirm:-

- a compulsory purchase order in respect of the land if an objection is made in respect of the acquisition by an owner, lessee or occupier of the land, and not withdrawn;
- an order which authorises the extinguishment, restriction or interference with a public right of way if there is an objection to the extinguishment, restriction or interference with a public right of way which is not withdrawn;
- an order which authorises the acquisition, restriction or interference with a private right if there is an objection to the acquisition, restriction or interference with the private right by an owner, lessee or occupier of the private right which is not withdrawn,

until it has considered the objection(s).

An Bord Pleanála has an absolute discretion under Section 218 of the Planning and Development Act 2000 (as amended) to hold an oral hearing.

Before making its decision on an application to confirm the Compulsory Purchase Order, the Board must consider any objection made and not withdrawn, any additional submissions or observations made pursuant to a request by the Board under Section 217A of the Planning and Development Act 2000 (as amended) and any report of the person who held the oral hearing, if such an oral hearing takes place.
